
WHAT'S HAPPENING AT THE ARTHRITIS ALLIANCE OF CANADA 2015 ANNUAL MEETING?

The 2015 Arthritis Alliance of Canada (AAC) Annual Meeting will take place October 22^{nd} - 23^{rd} at the Delta Lodge Hotel Kananaskis. The programme is focused on "Building Capacity for Sustainable Health Care in Canada." Read on for more details...

Thursday's programme will kick off with the **Research Symposium**; entitled "New Discoveries in Osteoarthritis (OA) Research." The session will look ahead at promising approaches for future studies, identify knowledge gaps and research opportunities and, pay tribute to the tremendous accomplishments and legacy of the late Dr. Cy Frank, our colleague, mentor, scientist, surgeon and dear friend.

The Friday morning programme features the *AAC Models of Care Workshop*, to identify ways to work together to improve sustainability of health care system in Canada. A *Research Workshop*, aiming to engage AAC members, partners and stakeholders in:

1) identifying knowledge gaps in osteoarthritis; 2) synthesizing and prioritizing key research questions that need to be addressed; and 3) identifying programs and strategies to tackle the most critical questions in osteoarthritis research.



The afternoon programme will continue with the *Advocacy and Awareness Workshop*, pursuing a review of political landscape across the regions, policy positions and key messaging on arthritis issues and hot topics; exploring strategies for participating in federal and provincial health policy formation; and mobilizing regional advocacy teams to engage in policy dialogue with a targeted approach.

The programme will conclude with a *joint poster session* with *IMHA Young Investigators*, *The Arthritis Society Trainees and Arthritis Consumer Organizations* in Canada". The Arthritis Consumer Organizations invite you to learn "who does what, where, why, when and how" at the Poster Session.

Making waves into medical cannabis research



This month, The Arthritis Society funded its first research into medical cannabis and arthritis pain. It did so in keeping with a new element of its research strategy, which is to explore the most promising avenues to help relieve pain itself for the millions of Canadians who live with arthritis. The ultimate goal of investigating the potential of medical cannabis is to help Canadians make informed choices about their arthritis treatment – and help their physicians give recommendations that are based in science. As it stands, up to two-thirds of people authorized by Health Canada to use medical cannabis are doing so to relieve arthritis pain.

With a three-year operating grant, Dr. Jason McDougall (Halifax) will examine the ability of cannabis-like compounds to repair joint nerves and relieve neuropathic pain from osteoarthritis. This stems from an emerging theory that part of osteoarthritis pain arises from damage to the nervous system rather than physical joint degeneration. Dr. McDougall's project was selected following an extensive multi- disciplinary peer review process that ranked competing submissions from outstanding Canadian researchers. Later this year, The Arthritis Society will convene the first national conference on medical cannabis bringing together key stakeholders to develop a shared plan to advance research in this field. COCHRANE CANADA

Many of our members are familiar with Cochrane Canada and its mandate to "...bring the use of evidence into healthcare policy and practice... by promoting the use and accessibility of Cochrane Reviews through the Cochrane Library." Indeed, people from all walks of life use Cochrane as a resource to find answers to enable them to make informed decisions about health related questions. In fact over the past two years, 231 Cochrane Reviews from 37 Cochrane Review Groups have been used in 65 Canadian clinical practice guidelines. Whether we know it or not, Cochrane Reviews are guiding the delivery and best health practices from the research bench to the patient/consumer bedside. What subscribers may not know is that effective September 2015 the Canadian Institute of Health Research (CIHR) will no longer fund Cochrane Canada. The loss amounts to approximately \$2 million per year and signals the end to Cochrane Canada unless new funding can be found.

Dr. Jeremy Grimshaw, Director of Cochrane Canada made the announcement at the Cochrane Symposium held in Calgary, Alberta on May 21-22, 2015. He explained that he was informed of the CIHR decision two years ago and has been working with CIHR and other funding agencies in an attempt to keep Cochrane afloat. Dr Grimshaw is hopeful that short-term funding can be found until long—term funding is secure. At this point you may be asking yourself, what can I do about the funding loss?

CANADIAN RHEUMATOLOGY ADMINISTRATIVE DATA (CANRAD) NETWORK



The CANRAD Network team includes a variety of decision makers, epidemiologists, clinicians and researchers interested in the use of administrative data for rheumatic disease research. We held our Spring Webinar at the end of May. Drs. Lisa Lix and Natalie Shiff presented their results looking at the validation of JIA/JRA using Manitoba data. The CAnadian Network for Advanced Interdisciplinary Methods for comparative effectiveness research' (CAN-AIM) team was funded by CIHR to develop novel methods using prospective longitudinal cohorts and to respond to key knowledge gaps regarding drug safety and effectiveness by answering queries which arise from Health Canada and other regulatory parties. Our demonstration project looked at the comparative effectiveness of anti-




tumour necrosis factor (TNF) agents versus traditional disease-modifying agents (DMARDs) in reducing orthopaedic surgery in rheumatoid arthritis (RA). HEALTH CANADA ADVISORY PANEL ON HEALTHCARE INNOVATION NEW REPORT

The report identifies five broad areas for innovation and improvements:

- patient engagement and empowerment
- health systems integration with workforce modernization
- technological transformation via digital health and precision medicine
- better value from procurement, reimbursement and regulation
- industry as an economic driver and innovation catalyst.

On Thursday, June 11th, OIRM hosted its first Health Charities Forum to bring together several health charities for whom stem cell and regenerative medicine research could have, or already has had an impact. The forum featured a patient advocate and her physician telling the story and science of her remission and presentations of OIRM's current Disease Team projects.
